A request for payment was presented from Terry Crater for CPO 34-2024-801 in the amount of \$10,000. Wes Schollander made a motion for approval. The motion was seconded by Mark Apple and it was passed unanimously.

A request for payment was presented from Terry Crater for CPO 34-2025-801 in the amount of \$324. Wes Schollander made a motion for approval. The motion was seconded by Mark Apple and it was passed unanimously.

The Area 2 Association of Soil & Water Conservation Districts requested a donation of \$50 to support the CET. Wes Schollander made a motion to approve the request. The Motion was seconded by Mark Apple and it was passed unanimously.
